A discussion of the positive benefits of a small area of wildflowers in the village was presented by Cllr. G. Leather. The Clerk reported that she had received two letters of objection and three in support of the proposals. Cllr. G. Leather reported that there was further support from the village Facebook group. A wildflower verge was proposed by Cllr. G. Leather, who suggested taking into consideration the comments of the two parishioners who objected by moving the location to the opposite side of the road. The proposal was seconded by Cllr. M. Bell. The remaining verges will be cut as per the usual schedule.

Little Ribston Parish Council approved a contribution of £50 towards the cost of the wildflowers.

Resolved: to approve and note the planting of one verge with wildflowers and to action the clerk to contact the contractor regarding the village grass cutting and removal of the turf on the wildflower verge.
